## **MRS. SONAL TRIVEDI, WHOLE TIME DIRECTOR**

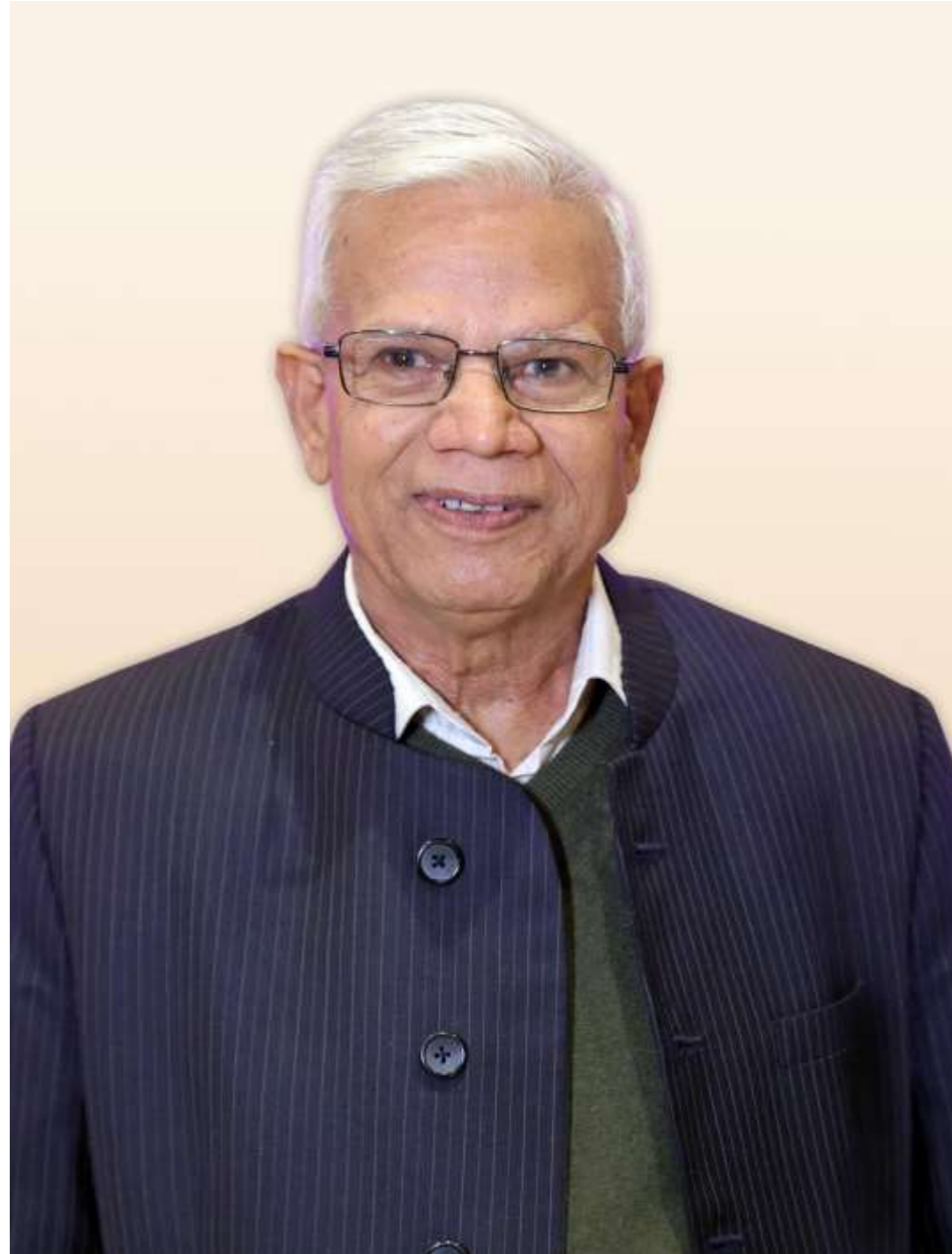
